Overview of Tab 2 by Tappia Infanger

Director Tappia Infanger reviewed Tab 2- Proposed Operations contained in the Charter as part of the education portion of the meeting. Charter education builds the foundation for all involved to become familiar with the school and how it is formed and operated.

New Business:

Discussion of committees to be formed

Discussion of committees to be formed is on hold. It was pointed out that year round schools alleviate overcrowding. However, the schedule of three on one off is hard on children. The new magnet high school where project based learning is the focus is already at 90% capacity, further emphasizing the need for additional schools, namely American Heritage Charter School. Despite AHCS not being

entitled the promise of having grades 9-12, they will push forward as if that is the case. The school dress code is non-negotiable. It was discussed why children sometimes don't continue their education within the charter for their high school years. The survey conducted by Professor Wang was noted as a good source for the benefits of staying within the charter for all years of schooling. It was pointed out that part of the senior experience is forming a small business which is started freshman year. Job shadowing and incorporation of heroes is part of this four year project.

Updates on the remodel of New Sweden Building, Trent VanderSloot

Director and Project Manager Trent VanderSloot shared that the architect is making tentative plans with the owner. It was suggested that a timeline of construction plans be provided for the Commission in preparation for the meeting on July 24th. Director Trent is still seeking for a contractor and brought up liability with contractors and insurance with waivers for all who work on the building or walk through it. It was discussed that people with a history associated with the school be contacted and that perhaps articles or alumni pictures be included within the finished project.
